Location

Motis Business Centre is prominently located alongside the M20 motorway at Junction 12 and overlooks the Channel Tunnel Terminal. Motis Business Centre situated on Cheriton Parc will provide a high quality business park environment with both office and leisure facilities. Nearby occupiers include Holiday Inn Express, Saga PLC and Tesco with development due on the adjacent land.


Communications are excellent, including the high speed rail service to London St Pancras with a journey time of less than one hour. Dover cross Channel ferry services is a 15 minute drive east, the M25 is easily accessible via the M20 and Eurostar services to Paris, Brussels and Northern Europe from Ashford International rail station just 20 minutes' drive to the west.

Description

Motis Business Centre was acquired by Motis Ireland Ltd in 2016 and is situated within Cheriton Parc in Folkestone, Kent. The building is in the process of being converted into high quality managed office suites with leisure facilities.

The building is approximately 29,000 sq ft over two storeys and is within a gated car park of 170 spaces.

The aim is to provide a range of flexible managed office suites, virtual offices



and serviced meeting rooms for not only the businesses within the centre but for the town itself. Motis aim to build a community within the centre by providing larger breakout areas with high quality amenities both inside and outside for the businesses.

Office suites will have the benefit of their own private entrance, a/c , fresh air intake systems, LED lighting, individual intruder alarm and electricity meters.




